C.R.S. 24-72-305.5 Access to records – denial by custodial – use of records to obtain information for solicitation Records of official actions and criminal justice records and the names, addresses, telephone numbers, and other information in such records shall not be used by any person for the purpose of soliciting business for pecuniary gain. The official custodian shall deny any person access to records of official actions and criminal justice records unless such person signs a statement which affirms that such records shall not be used for the direct solicitation of business for pecuniary gain.

Fire Investigation Reports, Classification of Fire Cause:

Accidental Fire Cause Classification. Accidental fires involve all those for which the proven cause does not involve an intentional human act to ignite or spread fire into an area where the fire should not be.

Natural Fire Cause Classification. Natural fire causes involve fires causes without human intervention or action, such as fires resulting from lightning, earthquake, wind, and flood.

Incendiary Fire Cause Classification. An incendiary fire is a fire that is deliberately set with the intent to cause a fire to occur in an area where the fire should not be.

Undetermined Fire Cause. Whenever the cause cannot be proven to an acceptable level of certainty, the proper classification is undetermined.

Potential Reasons for Application Denial of release:

- a. The fire investigation is still ongoing, case may still be active, and/or the case was criminal. If case is criminal the applicant may request a release or records from the appropriate law enforcement agency where the incident occurred.
- b. The fire incident was located in another fire jurisdiction, the applicant will need to contact the appropriate fire jurisdiction. The fire investigator will submit all reports and photos to the appropriate fire jurisdiction.
- c. In some circumstances only a NFIRS Fire Report will be available. Fire crews on scene were able to determine origin and cause and did not have to request a Fire Investigator to the scene.
